NOW THIS INDENTURE WITNESSETH AND IT IS HEREBY AGREED AND DECLARED AS FOLLOWS:

1. Name of the Trust:

The Trust hereby declared and constituted is a Public Charitable Trust and be designated as "ALM CHARITABLE TRUST".

2. Objects of the Trust:

- a) To impart education with modern and latest technologies; to make the education as the contributor to the refinement, application to the moral, material and spiritual progress.
- b) To promote moral values among the general public by inculcating sense of responsibility towards individual, society and the nation; adopting ways and means to eradicate illiteracy, prejudices, hatred, mistrust and misunderstanding; resorting to methods helpful in creating sense of wise and virtue, sensibility to human values, brotherhood of humanity and anything which is desirable and good in the interest of achieving and promotion of moral values.
- c) To establish, take over, construct, acquire, own, run, maintain, manage, help and make donations to, Schools, Colleges, Universities, Hospitals, Institutions, Hostels, Libraries, Training Center, Study Centers, Orphanages, Crèches, Old Age Homes and Educational, Cultural, Social, Vocational and Medical Institutions, and Recreational Centers.
- d) To donate or gift either in cash or in kind, support, help, aid, subsidize, and render financial assistance to aged, poor, needy and deserving cases for medical, educational and all individual causes and institutions which have objects similar to the objects of the Trust.
- e) To conduct personnel skill development, awareness programme about the employment opportunities, educational, training centers for higher studies, counseling centers for deserving students to get higher studies, providing employment.
- f) To conduct leadership and management-oriented courses, institute awards, trophies, etc., for people who shine in any field particularly for the development of Human resource and to those who have served the community in an exemplary manner.
- g) To render financial assistance to the poor and needy in the form of alms or loans with or without compensation on the terms and conditions that may be decided by the trust then and there.
- h) To organize functions on various occasions, award prizes, assistance of any type and nature and work for the communal harmony, unity and for the upliftment of the society, humanity and nation.
- i) To establish and provide guidance and counseling centers to the members of the society.
- j) To award prizes to students for proficiency in any subject or language.
- k) To give food, clothing and alms to the poor for marriages and other social and moral customs and practices in all possible ways and manners.

- l) To render manpower services for the placements of the deserving candidates.
- m) To establish construct, take over, acquire, own, maintain, manage, help, run, contribute and sponsor Community Halls, Marriage Halls, Prayer Halls, Auditoriums, Moral and Spiritual Study Centers, Places of Public Worship and Use, etc.
- n) To institute and award Scholarships, Grants, Stipends, Loans etc., for study and research persons deserving help and encouragement enabling them to continue their studies and to award prizes to students for proficiency in any subject or language.
- o) To engage spiritualists, specialists, teachers, instructors and other staff to carry on the work of the Trust and to terminate them on superannuation or otherwise.
- p) To accept donations, grants, presents and gifts, either in cash or kind, for the purposes of the Trust and to adopt all lawful courses, means and measures for raising funds for the Trust.
- q) The activities would be purely charitable nature and not motivated for profit.
- r) To do all lawful acts and deeds as are incidental or conducive to the attainment of the above objects and to do such other acts and things as the Trustees with majority, may decide then and there.
- s) The objects mentioned above are independent of each other and the Trust may from time to time, decide to apply the funds of the Trust for carrying out all or any of the aforesaid objects.
- t) To do in all public, charitable activities for public benefit without any discrimination of Caste, Creed, Color, Gender, Religion, Faith or Race, that falls within the meaning of section 2 (15) of the Income Tax Act, 1961.

3. Donations and Contributions

The Executive Committee shall have power and discretion to accept upon such terms as they shall think fit donations, grants, subscriptions, aids and contributions from the Settlers and Trustees and from any Government, Local Authority, Corporation, Company, Firm or other persons or from any charitable or other institutions whether be in cash or kind for the purposes of the Trust, provided always that the terms upon which they shall be accepted shall not in any way be inconsistent with or repugnant to the provisions contained in these presents. The Trust shall apply such donations, Grants, aids, subscriptions and contributions for all or any of the objects of the Trust keeping in view as far as possible the intentions of the Donors.

4. Trustees

- i. The above mentioned Settlers are being appointed as the Life Trustees of the Trust to hold their respective office for their life.

- ii. A Trustee shall cease to hold the office by (a) Resignation (b) Death (c) Unsound mind (d) Insolvency.
- iii. A Trustee may also be removed from the office, with the consent of at least 3/4th majority of the Trustees for doing any unlawful deeds, which may be detrimental to the objects and interest of the Trust and shall be given at least a fortnight's notice to submit his explanation, either in person or in writing, before the resolution is passed.
- iv. The Trustees mentioned in sub clause (i) supra, shall hold the office for their life, with the succession right, as mentioned in sub clause (v), infra unless otherwise stated in the terms of appointment.
- v. Any vacancy arising in the Life Trustees be filled with a successor of the Trustee, as maybe nominated by him during his life, if no one is nominated, the legal heirs may appoint any one of them to succeed and if more than one person claims the appointment, the Board of Trustees, may appoint any one of his heirs to be the Trustee.
- vi. Any person, satisfying the qualification as may be decided and prescribed by the Board of Trustees may be appointed as the Trustee, with a simple majority in the meeting of the Board of Trustees, on the terms and conditions and for the period as may be decided then and there.
- vii. The Properties and investments belonging to the Trust be vested in the Trustees for the time being. On any Trustee ceasing to be a Trustee, the Trust properties and investments shall cease to vest in him and on the coming of any new Trustee, the Trust properties and Investments shall vest in the new Trustee along with the other continuing Trustees.

5. Proceedings of the Meeting of the Board of Trustees

- i. The Board of Trustees shall be the overall custodian of the Trust properties.
- ii. The Board of Trustees shall meet at least once in three months, which meeting shall be convened by the Managing Trustee on a notice of at least 15 clear days, which shall be chaired by him.
- iii. The Managing Trustee shall also have to convene a meeting of the Board of Trustees at the registered office, on the request from at least 50% of the members of the Boards of Trustees.
- iv. The Agenda for the Meeting mentioned in sub clause (iii) supra shall be, as specified by the members of the Board of Trustees, requesting for the meeting.
- v. All the activities of the Trust be reviewed by the Board of Trustees.
- vi. The Quorum for the meeting of the Board of Trustees shall be at least 1/2 of the then existing Trustees.







- vii. If there is no quorum for the meeting, the meeting shall get adjourned to the same day, same time of the next week, at the Registered Office. The members present at the meeting shall be the Quorum.
- viii. Minutes be maintained for the Meeting of the Board of Trustees and be circulated among all the Trustees.

6. Powers and Functions of the Board of Trustees

- i. All the powers, funds and assets of the Trust shall vest with the Board of Trustees, who shall have custody and control of all the documents, accounts, papers and other matters relating to the Trust and its properties and shall have all the powers while carrying out the objects of the Trust.
- ii. Subject to the general provisions of the Trust and without prejudice to the general and specified powers conferred upon by the other provisions contained in these presents, the Board of Trustees shall have the following powers also:
 - (a) To apply the Trust money to effectuate one object or some of the objects of the Trust in preference to the other.
 - (b) To discontinue the application of Trust funds to one object and divert to other objects.
 - (c) To decide the nature, objects and functions of the institutions to be established by the Trust and to decide whether existing institutions(s) may be taken over by the Trust or to which financial aid may be provided.
 - (d) In case it is decided to render financial or other aid to any institution, to decide as to the terms and conditions.
 - (e) To determine the terms and conditions on which donations, aids, subsidies, subscriptions, scholarships, or prizes are to be awarded by the Trust.
 - (f) To expend the funds of the Trust in such manner as they shall consider most beneficial for the purposes of the Trust.
 - (g) To carry on or manage any business in which the funds of the trust may be invested.
 - (h) To acquire, build upon, pull down, rebuild, add to, alter, repair, improve, sell or dispose off or otherwise deal with any land, building or premises for/of the Trust.
 - (i) To take or give any property on lease or hire.
 - (j) To acquire any property in exchange for some other property of equivalent value or on payment of consideration.


- (k) To enter into any contract on behalf of the Trust.
- (l) To borrow money with or without security and to grant or execute mortgage for securing the same and upon such terms and conditions as may be decided then and there.
- (m) To make and from time to time repeal, add or alter the regulations, of the Trust.
- (n) To settle out of court, compromise and compound all suits, actions and other proceeding and all differences and demands, to refer all or any of such differences or demands, to enter arbitration and to execute, release and to settle and improve all accounts without being answerable for any loss occasioned thereby.
- (o) To appoint and terminate managers, secretaries, clerks and other staff.
- (p) To open and operate Bank Accounts as per the terms and conditions as may be decided then and there.
- (q) To assign and delegate any job or its powers to any single member or groups of members.
- (r) The Board of Trustees shall have all powers in the course of carrying on the activities and services.
- (s) All the documents, negotiable instruments, contracts, etc., shall be executed as per the majority decision of the Board of Trustees.
- (t) In case of any dispute among the Trustees and between the Trust and the Trustees, the decision of the Board of Trustees shall be final.
- (u) To negotiate and fix from time to time, the interest, rent, charges, etc., payable, including those to the Trustees.
- (v) To appoint, hire and remove the services of employees and professional bodies.


7. **Managing Trustee**


Mr.Karai Shandu Mohamed Kadher Batcha, shall be the First Managing Trustee, whose appointment shall be valid for three years and is subject to get reappointed for such periods, with the majority decision of the Board of Trustees.


8. **The Office of the Trust**

- (i) The Office of the Trust shall be situated in a rental building at No. 100-B, Podanur Main Road, Milekal Stop, Coimbatore - 641023.
- (ii) The Board of Trustees may shift the office to any place as may be decided upon, from time to time.

- (iii) The Board of Trustees may also decide to have the place of work in more than one place, as may be decided upon, from time to time.

9. Accounts and Audit

- (i) The Managing Trustee shall keep proper accounts of the Trust and shall prepare the financial statements every year as of the last day of March. If any business, trade or industry, is carried on, a separate set of books of accounts shall be maintained in connection therewith.
- (ii) The accounts of every year shall be audited by a Chartered Accountant who shall be appointed for the purpose, by the Board of Trustees and the audited accounts shall be placed and passed at the meeting of the Board of Trustees, convened for the purpose, which shall be held within six months from the end of the financial year.

10. Beneficiary & Irrevocability

- (i) It is hereby declared that the Trust is a Public Charitable Trust, and it shall not carry on any activity with the intention of making profits.
- (ii) Trust hereby created is irrevocable and the beneficiaries under this Trust shall not be restricted to any particular religion, caste, creed or community.

11. Dissolution

- (i) If the Trust is unable to function by whatever reason, the Board of The Board of Trustees with at least 75% of the majority shall have the power to associate or amalgamate with other trust constituted for similar purposes and recognized under the Income Tax Act 1961 or to assign the Trust Properties in favor of such other trusts.
- (ii) In the event of dissolution or winding up of the Trust it shall be amalgamated or associated with other trusts constituted for similar purposes and recognized under the Income Tax Act, 1961 and the Trust properties shall be assigned in favor of such other trusts.





12. Alteration to the Clauses of this Indenture

Any amendment of this Trust shall be carried out only with the approval of the Commissioner of the Income Tax (Exemptions).

13. Utilization

The Income and Funds of the Trust shall solely be utilized towards the fulfillment of the objects of the Trust and shall not be utilized for payment to Trustees by way of sharing of Profit.
